Nominations for intersessional committees

Dear Madam/Sir,

At its Sixth Session, the Governing Body reconvened some intersessional committees and decided to establish new ones. Some regions advanced on the nomination process during the session and provided the name of the country and/or the expert, while others announced that they would do so after the Session.

The purpose of this notification is to invite Contracting Parties to consult at national and regional level on the remaining nominations and submit them to the Secretariat through their respective regional vice-chairperson¹. During the Session, all regions already renewed the composition of the Compliance Committee, so it has been excluded from this notification. The early submission of the pending nominations will facilitate the consultation and planning processes for the following committees:

- Ad Hoc* Advisory Committee on the Funding Strategy (ACFS)
- Ad Hoc* Open-ended Working Group on the Enhancement of the Functioning of the Multilateral System of Access and Benefit Sharing (OEWG-MLS)
- Scientific Advisory Committee on Article 17 (SAC-GLIS)
- Ad Hoc* Advisory Technical Committee on Sustainable Use (ACSU)
