The Commission at its meeting in May 2013 revised the process for the administration of the MPF. As the main goal of the MPF is to increase the participation of scientists of developing CPCs to scientific meetings of IOTC, and in line with paragraph 6 of the Resolution 10/05, applications to the MPF will only be considered if the applicant is eligible and intends to produce and present a working paper, relevant to the work of the working party that he or she wishes to attend.

The organizer has pre-reserved rooms in the closest hotels. Please ask when making your reservation. It is recommended to proceed with your reservation as soon as possible. Meeting Participation Fund recipients should not make their own bookings.

6. Arrival and entry formalities

Participants should make their own arrangements for their entry visa in Reunion Island and it is recommended to do so **as soon as possible**. Failure to initiate VISA arrangements within the next weeks will likely result in a non-issue of a VISA in time for the meeting.

Assistance could be done by the contacts from Reunion Island Regional Committee for Sea Fisheries and Aquaculture.

For entering Reunion Island, passports or ID cards are required for French citizens and people from the rest of the European Union. A visa is required for citizens of all other nations.

Note: Reunion is not in the Schengen Zone, which means visas for mainland France are not valid. Contact an embassy or the French consulate.

7. Transportation

Some hotels can provide taxi services from the airport to the hotel.

Care hire companies are available at the airport (Europcar, Avis, Budget...).

Public transport in and around Roland Garros international airport includes taxis and buses.

However, most of the recommended hotels are in close vicinity of the venue.

8. Dress code

9. Delegates kit

Electricity in Reunion Island is 220/230 volts AC, 50 Hertz. It is recommended to delegates to bring adequate adaptors with them even if some will be available.

Mobile services:

There are three mobile service operators (SFR, Orange, Only) and they can be found on arrival at the airport. They offer SIM card and prepaid recharge for mobile phones.

12. Internet

Wi-Fi facility will be available in the conference area.

Internet service at hotels and outside the conference area will be at participants' own expense.

13. Currency and exchange

The currency in Reunion island is the Euro (€). The current exchange rates are (8/07/2013):

1 € = 1.28134 USD

1 € = 0.8616 British Pound

The change of currency in Reunion Island is not usual.

It is advisable to get itself euros before the arrival to Reunion Island. Nevertheless, all major credit cards can be used in Reunion Island.
